

# Noblelift Standard Warranty Aerial Work Platform

**Warranty registration must be completed and registered with Noblelift Canada Inc. before claims are processed.**

Noblelift Canada Inc. warrants that each new Noblelift Aerial Work Platform to be free, (under normal use and when the manufacturer's maintenance guidelines are followed) of defect in material and workmanship for the first 12 months from the date of first use by the original purchaser from an Authorized Noblelift Dealer.

## Major component Warranty Coverage – 24 months or 2,000 hours

Noblelift Canada Inc. warrants each new Noblelift A.W.P Electric Drive Motor, Electric Pump Motor, Hydraulic control valve and lift cylinder to be free, under normal use and when the manufacturer's maintenance guidelines are followed, of defects in material and workmanship for the first 24 months or 2,000 operating hours (whichever occurs first) from the date of first use by the original purchaser from an Authorized Noblelift Dealer.

## Coverage

During the specified warranty period all manufacturer's scheduled maintenance must be performed and documented by the Authorized Selling Dealer, Distributor or Factory Trained Personnel utilizing OEM original parts, any defect in material or workmanship of the warranted item shall be repaired or replaced at Noblelift's option, by an Authorized Noblelift Dealer.

## Exclusions & Limitations

1. Items that require replacement during normal operation (such as, but not limited to, brakes, DC motor brushes, oil & filters, light bulbs, tires & wheels)
2. Repair or replacement required as a result of: (a) accident, (b) lack of proper maintenance, as outlined in the Noblelift Service Manual, (c) repairs or replacement of parts not properly performed, (d) use of replacement parts not of Original Equipment Manufacturer's origin that adversely affect the proper operation, performance, and/or durability, (e) Alterations or modifications performed without Noblelift's prior written approval, (f) deterioration of appearance or performance due to normal use or exposure.
3. Normal service repairs (such as but not limited to P.M. maintenance, tire replacement, adjustments, tightening of loose hardware, etc.)
4. Accessories or parts either installed by the Authorized Noblelift Dealer or that may be warranted by the original manufacturer (such as, but not limited to, attachments, tires, batteries, etc.)
5. Warning decals and informational decals will not be covered under this warranty.
6. Customer's or dealer's failure to implement any repair, update, or modifications to the Noblelift lift truck or products as recommended by Noblelift.
7. The warranty shall be void, if upon the occurrence of any incident involving any product made by Noblelift and resulting in any personal injury or property damage, customer shall fail to notify Noblelift within 48 hours of such occurrence or permit Noblelift and its representatives to have immediate access to such product and all records of or within the control of customer relating to the product and occurrence.

THE REMEDY UNDER THE WARRANTIES CONTAINED HEREIN IS LIMITED SOLELY TO THE REPAIR OF DEFECTS IN MATERIAL OR WORKMANSHIP BY AN AUTHORIZED NOBLELIFT DEALER AT ITS PLACE OF BUSINESS OR, AT NOBLELIFT'S OPTION, AT THE PLACE WHERE SUCH INDUSTRIAL TRUCK IS MAINTAINED, DURING CUSTOMARY BUSINESS HOURS. NOBLELIFT WILL NOT BE LIABLE FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES SUCH AS INCONVENIENCE OR LOSS OF USE OF THE NOBLELIFT INDUSTRIAL TRUCK TO THE USER, RESULTING FROM BREACH OF THE WRITTEN WARRANTY OR ANY IMPLIED WARRANTY. THE WARRANTIES CONTAINED HEREIN ARE EXPRESSLY IN LIEU OF ALL OTHER WARRANTIES, EXPRESSED OR IMPLIED, INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE AND OF ANY OTHER OBLIGATION OR LIABILITIES ON THE PART OF THE MANUFACTURER AND DISTRIBUTORS OF NOBLELIFT INCLUDING EXPENSE LOSS OR DAMAGE WHETHER DIRECT INCIDENTAL CONSEQUENTIAL OR EXEMPLARY ARISING IN CONNECTION WITH THE SALE OR USE OF OR INABILITY TO USE THE NOBLELIFT TRUCK FOR ANY PURPOSE. NO AUTHORIZED NOBLELIFT DEALER IS PERMITTED OR AUTHORIZED TO CHANGE, MODIFY OR AMEND ANY TERM OF THE LIMITED WARRANTY.
